This degree is offered to candidates who have achieved distinction in the analysis of music and who demonstrate ability to do research and scholarly study.

I. Credit Requirements

The Doctor of Philosophy degree requires a minimum of 94 semester credits beyond the bachelor's degree. Thirty (30) credits from the master's degree count toward the 94, and the remaining 64 credits are completed at FSU (40 credits of coursework plus 24 credits of Dissertation). Note: If the student received the Master's degree from the College of Music, all graduate-level credits (except remedial History and Theory) count toward the Doctorate.

II. Diagnostic Examination

This examination, which constitutes the final admission to the degree program, must be passed no later than the first semester in residence.

III. Residence Requirements

A minimum of twenty four (24) graduate credits must be earned during any consecutive 12-month period.

IV. Language Requirements

Demonstrated reading proficiency in two foreign languages is a requirement for the PhD in Music Theory. Requirement can be met either with the Reading Knowledge Class or the Reading Knowledge Exam.

V. Competency Examinations

Offered each semester on keyboard harmony, harmonization, and music literature that graduate theory and composition students must complete in order to graduate.

NOTE: MUH 5219 and MUT 5051 are remedial (or review) courses, and they do not fulfill degree requirements under any circumstances. There are no exceptions to this policy.

These courses address past curricular deficiencies and/or comprehension levels of core curricular content, as determined by proficiency examinations. Successful completion of these remedial (review) courses prepares students for graduate-level content courses in the disciplines of Music History and Music Theory.

Additional remediated coursework may be required of a student, as determined by Area faculty.
